A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE APPROVING THE ANNEXATION OF TERRITORY TO THE SILVER CREEK COUNTRY CLUB GEOLOGIC HAZARD ABATEMENT DISTRICT (GHAD)

WHEREAS, on March 31, 1992, the Council of the City of San Jose by its adoption of Resolution No. 63609, approved the formation of a geologic hazard abatement district for the Silver Creek Valley Country Club project area ("GHAD"), including the ultimate boundaries of the territories within the GHAD as more particularly described in the petition for formation; and

WHEREAS, on June 11, 1992, the Board of Directors of the GHAD, by its adoption of GHAD Resolution No. 92-04, a copy of which is attached hereto as Exhibit 1, ordered the annexation to the GHAD of the territory described on Exhibits A and B of GHAD Resolution No. 92-04; and

WHEREAS, the Council of the City of San Jose concurs that the health, safety, and welfare of the residents of said territory proposed for annexation requires annexation of said territory to the GHAD.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE:

SECTION 1: The Council hereby approves the annexation to the GHAD of the territory identified on the Legal Description and the Map of the Boundaries of the Territory to be Annexed to the District attached as Exhibits A and B, respectively, to GHAD Resolution No. 92-04, Exhibit 1 hereto .

GHAD RESOLUTION NO. 92-04

RESOLUTION OF THE BOARD OF DIRECTORS OF THE SILVER CREEK VALLEY COUNTRY CLUB GEOLOGIC HAZARD ABATEMENT DISTRICT ORDERING THE ANNEXATION OF TERRITORY TO THE DISTRICT

WHEREAS, on June 11, 1992, the Board of Directors adopted Resolution No. 92-03, initiating proceedings for the annexation of the territory described in *Exhibits "A" and "B"* to the geologic hazard abatement district for the Silver Creek Valley Country Club project area ("GHAD"), and setting a public hearing on the filed petition for the annexation to the GHAD of said territory; and

WHEREAS, all owners of real property within the boundaries of said territory submitted to the Clerk of the GHAD written waivers of the notice and time period requirements for holding a public hearing; and

WHEREAS, at the time set for hearing, no owner of real property within the boundaries of said territory had made a written objection to the annexation of said territory to the GHAD; and

WHEREAS, it appeared at the hearing that owners of more than 50 percent (50%) of the assessed valuation of said territory did not object to the annexation of said territory to the GHAD, and the Board of Directors thereupon closed the hearing; and

WHEREAS, the proposed annexation of said territory to the GHAD is not subject to the California Environmental Quality Act or the Cortese-Knox Local Government Reorganization Act of 1985, in accordance with Public Resources Code Sections 26559 and 26560; and

WHEREAS, the Board of Directors finds that the annexation of said territory to the GHAD is in the interest of the public health, safety and welfare of the residents of said territory.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE SILVER CREEK VALLEY COUNTRY CLUB GEOLOGIC HAZARD ABATEMENT DISTRICT:

1. The Board hereby orders the annexation to the GHAD of the territory described in Exhibits "A" and "B", subject to approval by resolution of the City Council of San Jose.
